- ARP S.A. provided cash contribution, know-how and ongoing support

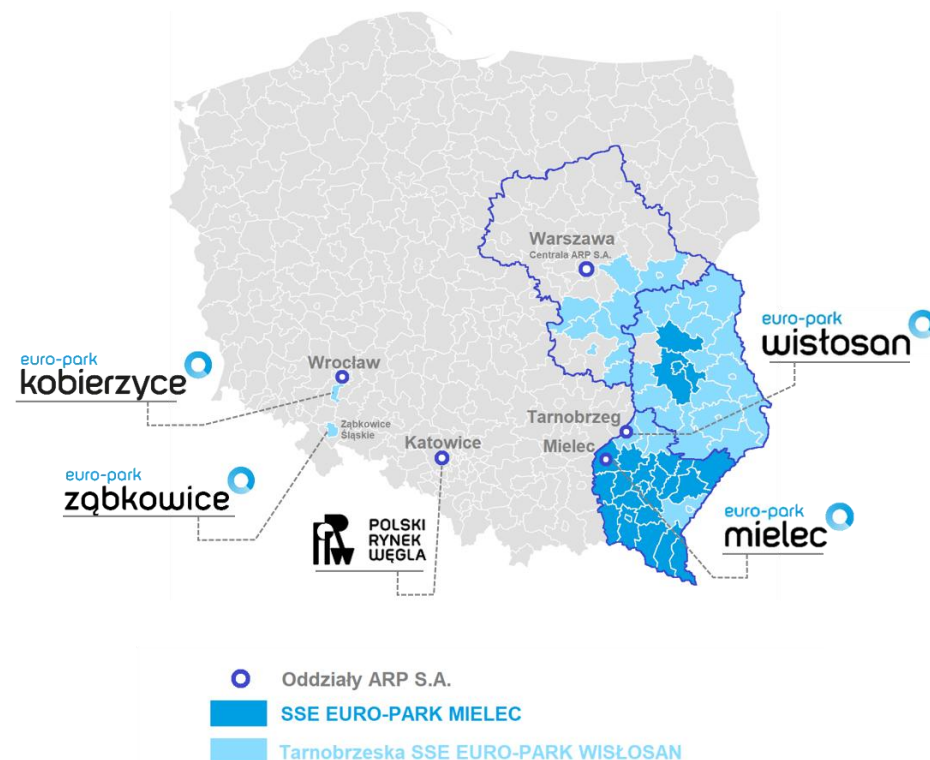

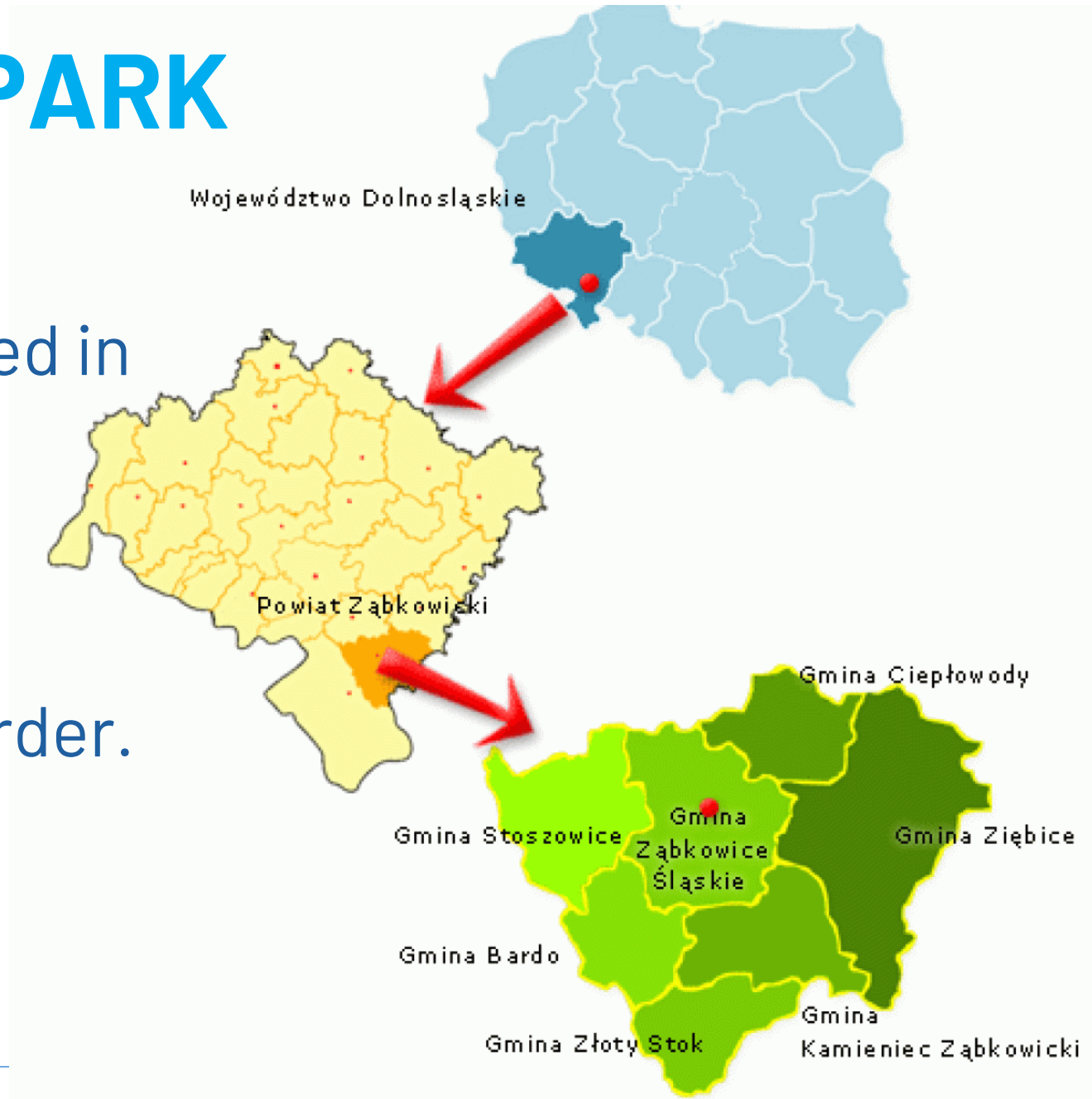

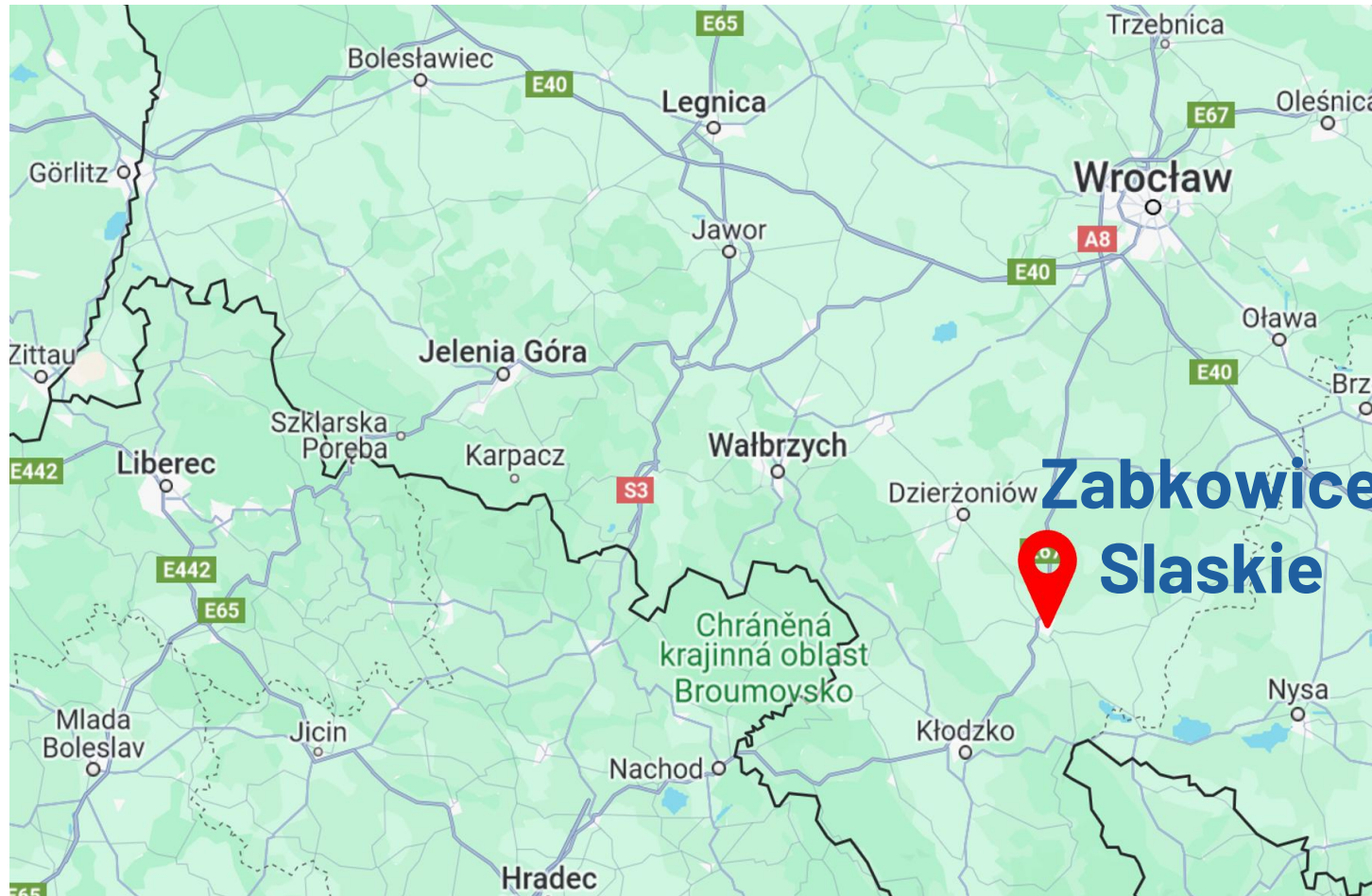


# Location of EURO-PARK

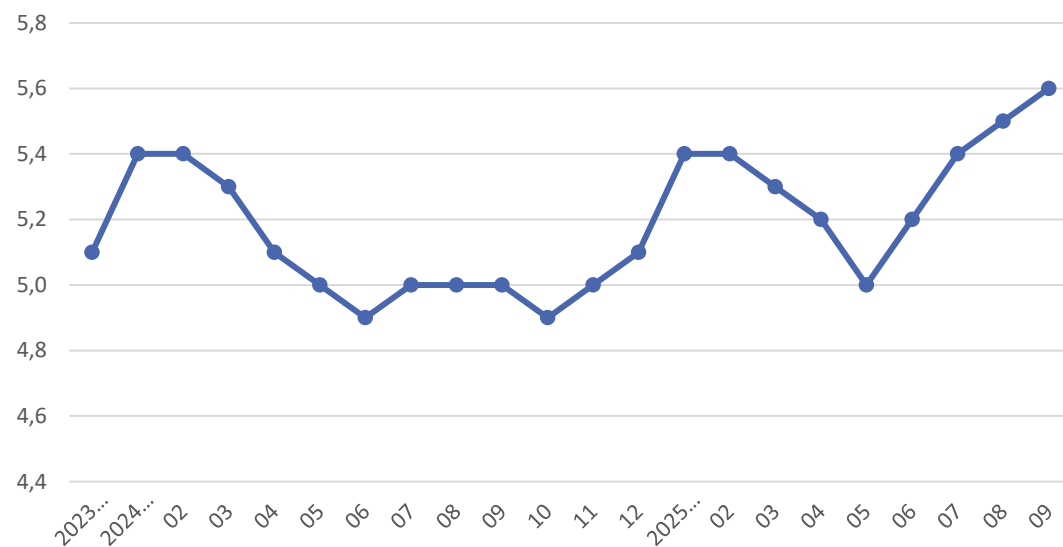

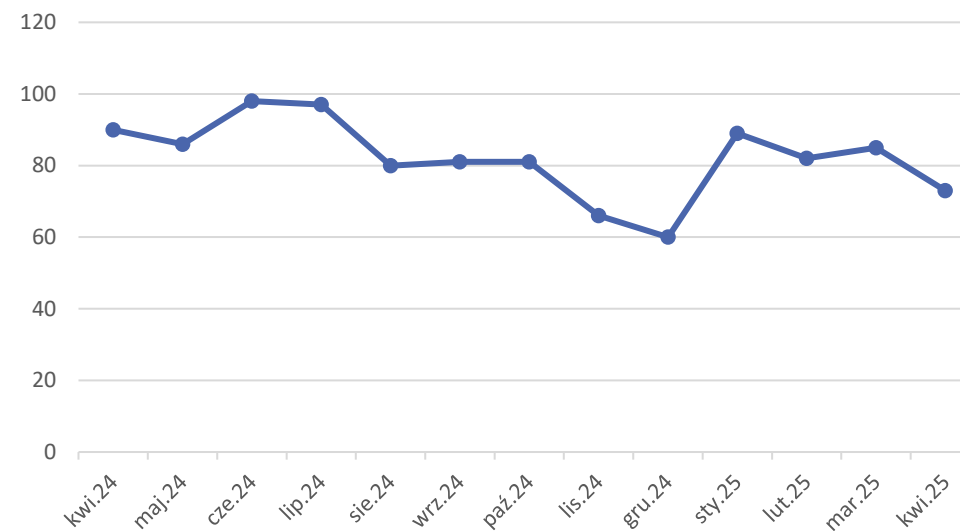

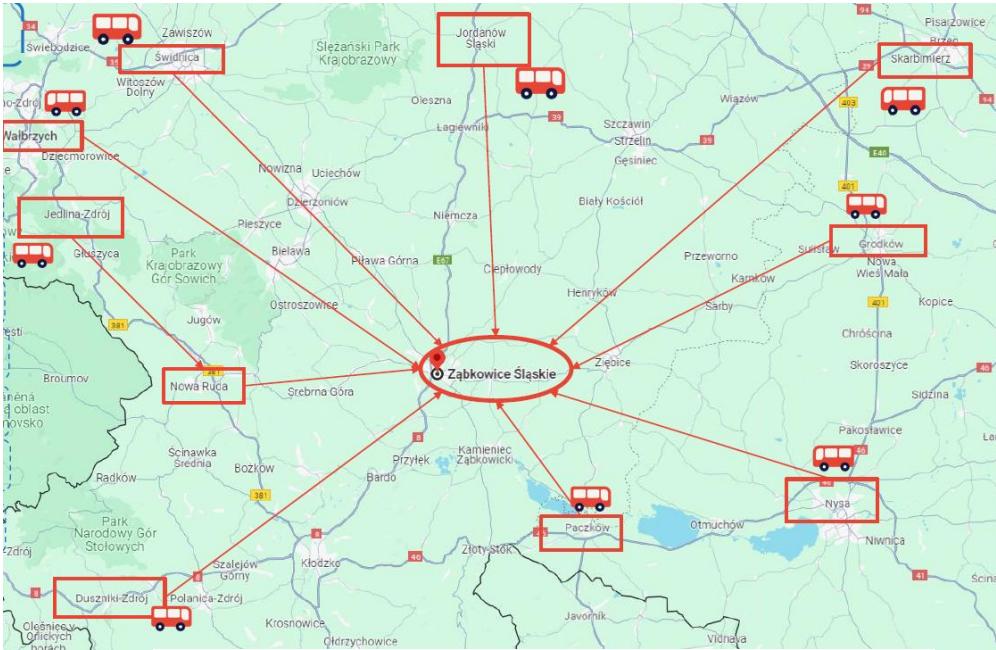

- By the S8 expressway (under construction)



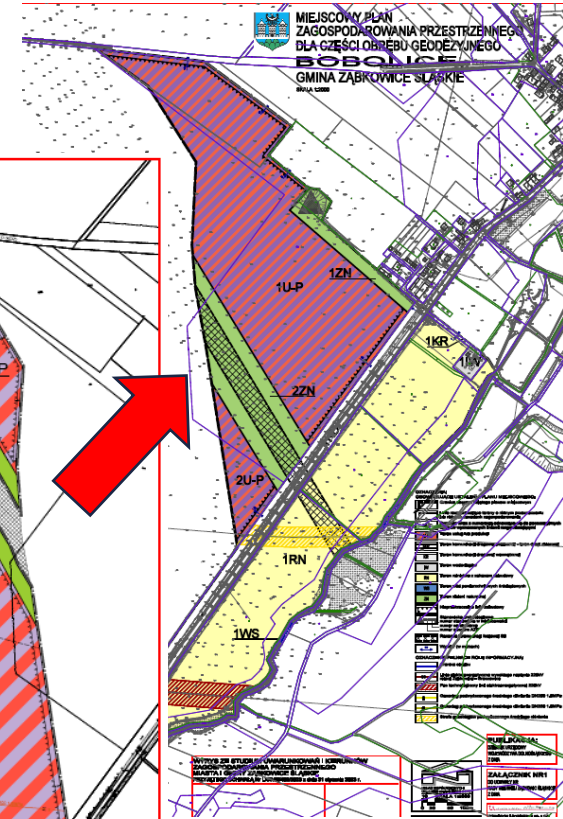
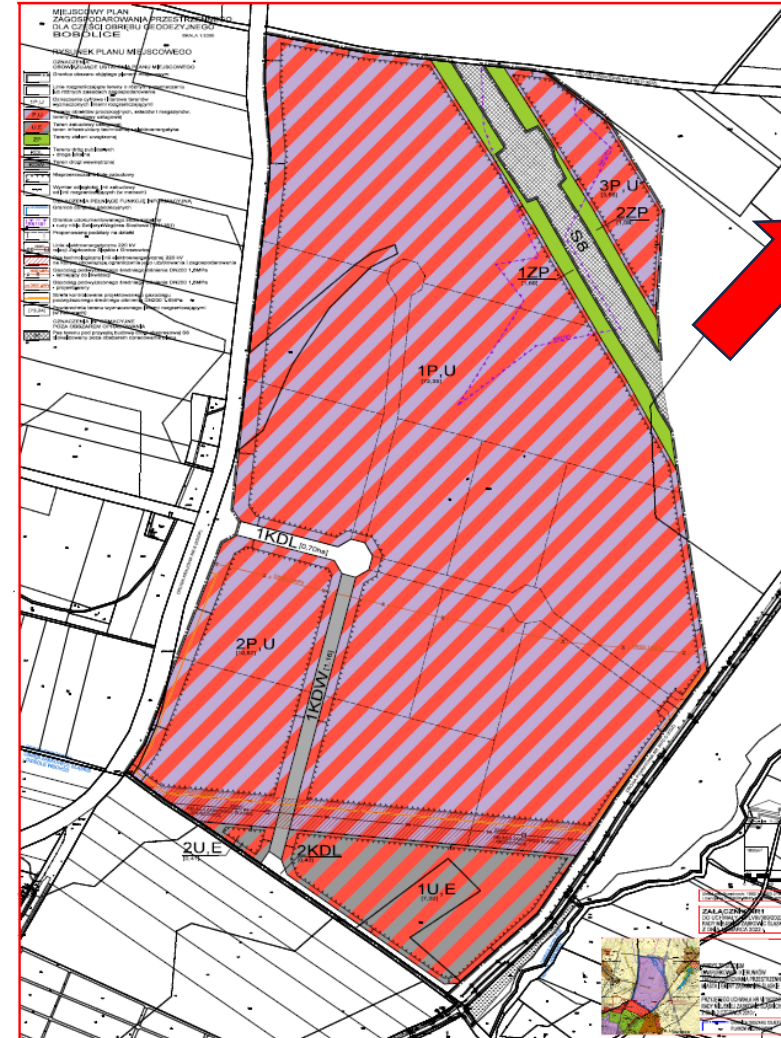

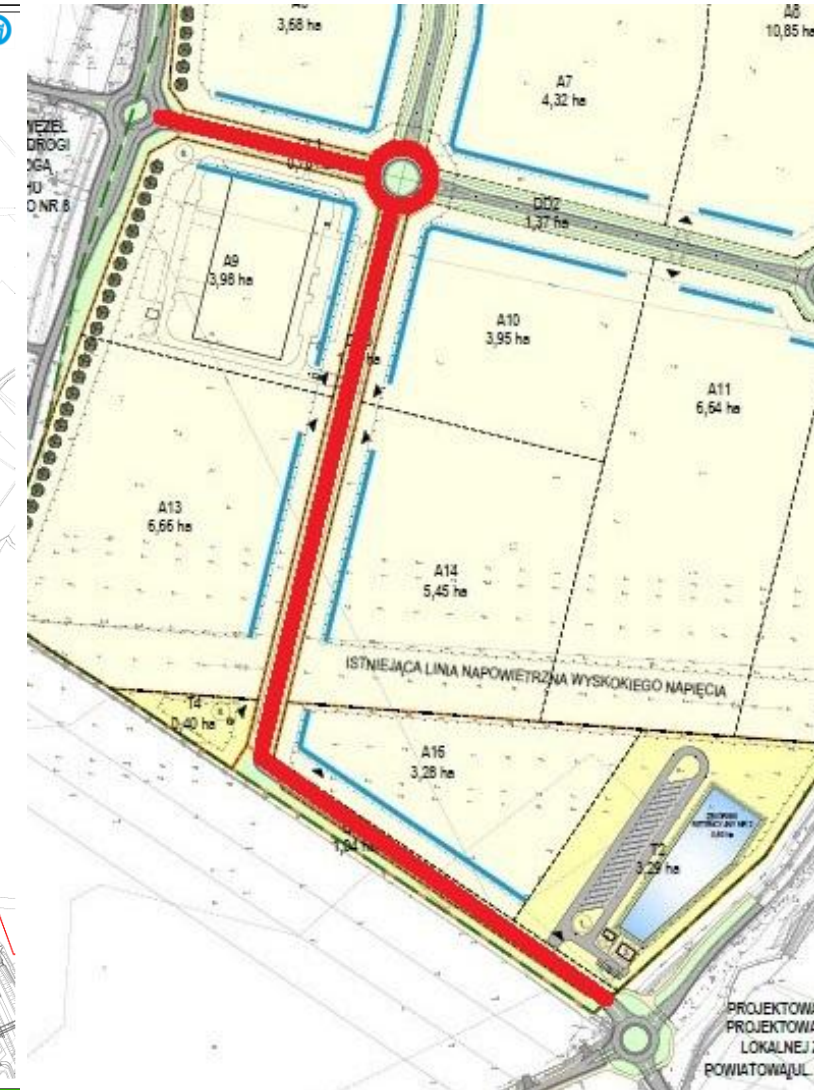
## Arrangements of the Local Spatial Development Plan

- **P,U Areas** – production facilities, warehouses and storages, service development areas
- **U,E Areas** – service buildings, technical infrastructure, power utilities
- **ZP Areas** – areas of decorated greenery
- Possibility of installing **photovoltaic devices**
- **1 parking space/5 workstations**
- Groundwater occurs locally at 1.30–2.0 m below ground level

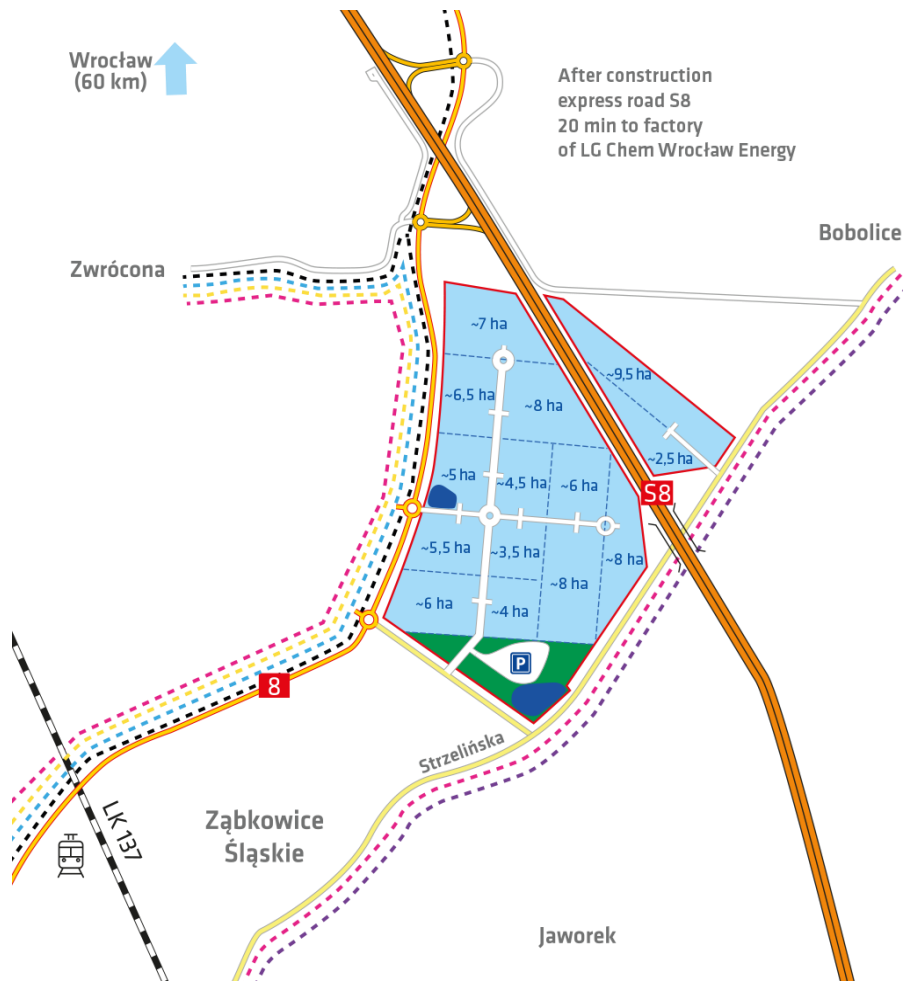

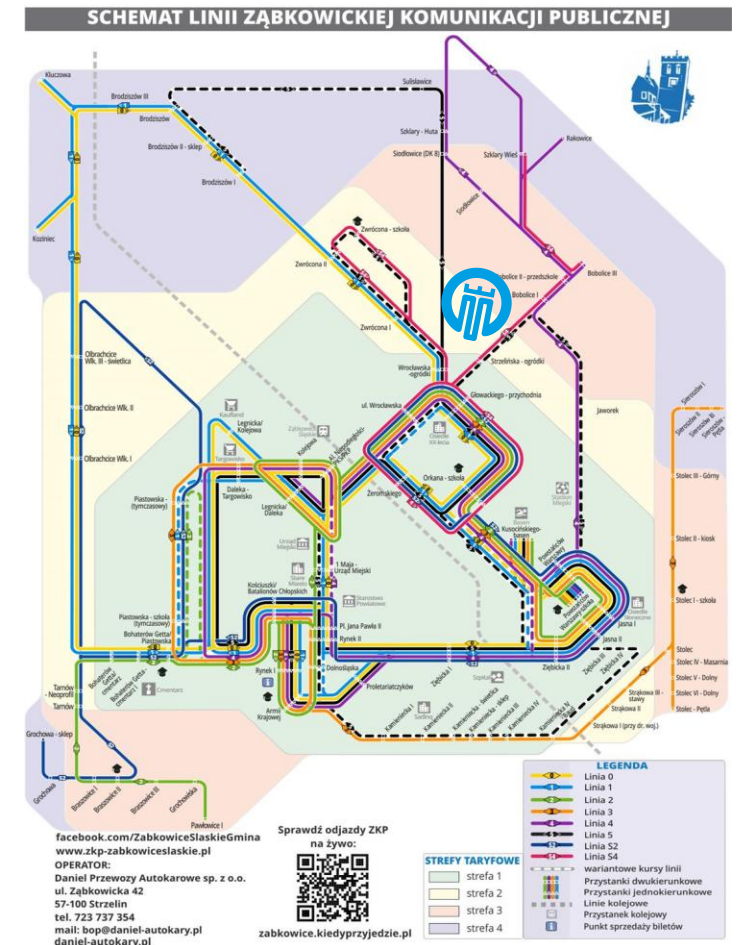

The construction of the S8 expressway between Wrocław and Kłodzko has been divided into seven investment tasks, which are at various stages of preparation or implementation.

Sections 1–3 (Kobierzyce–Łagiewniki) are the most advanced – it obtained ZRID decisions and construction work has begun.

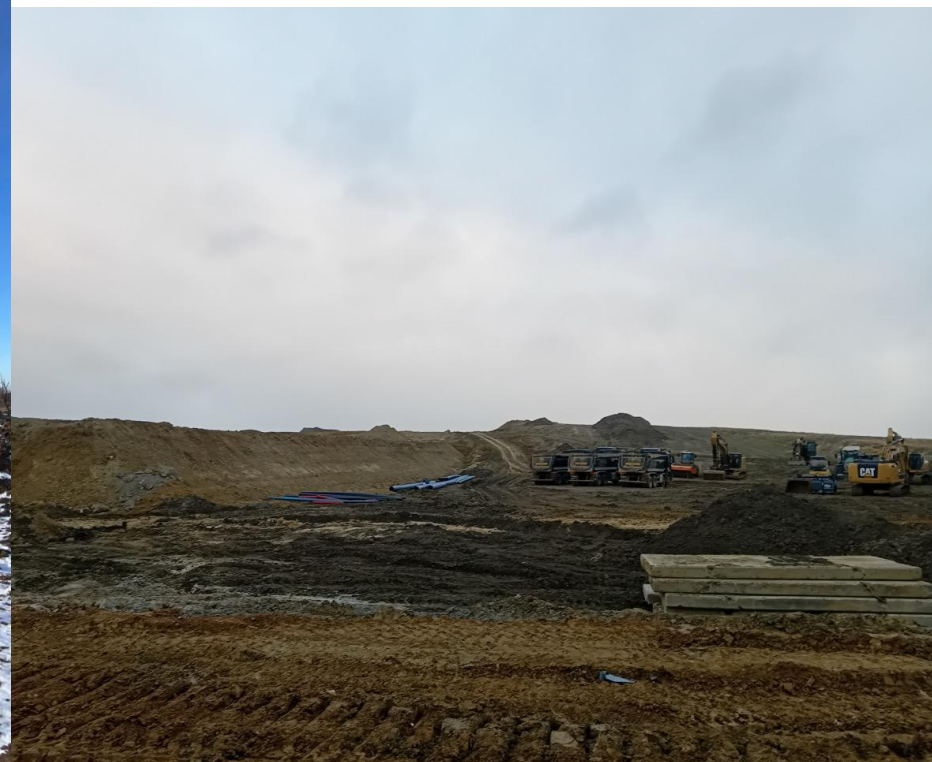
Sections 5 and 6, running through the EURO-PARK Ząbkowice area, are at the stage of obtaining ZRID decisions – applications have been submitted, and decisions are expected in 1Q2026.

Section 7 (Bardo–Kłodzko) remains at the stage of preparing environmental and study documentation (ZTEŚ).



# Budowa S8

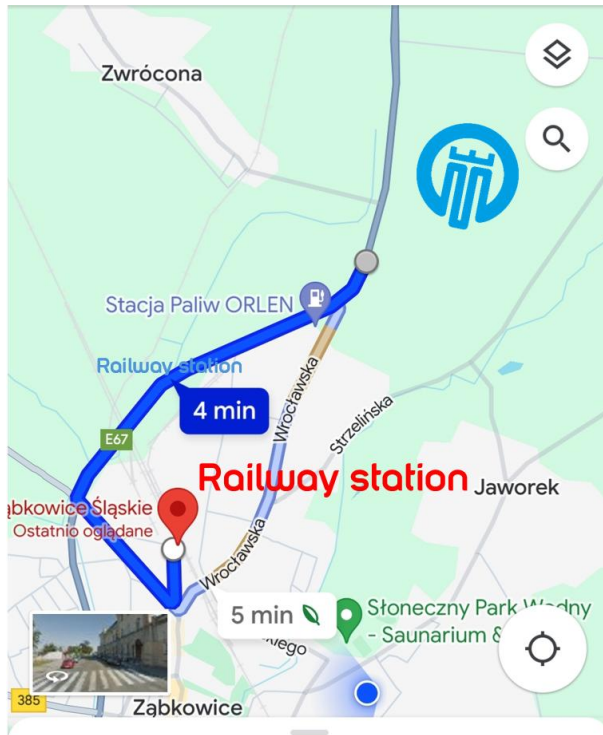
Work progress on S8 Wrocław-Kłodzko by sections

# Railway

- **Distance from the plot - 3 km**
- Ząbkowice Śląskie railway station is a local station
- Direct connections to bigger cities like Kraków, Jelenia Góra and Wałbrzych; daily routes to smaller: Kłodzko, Kudowa Zdrój, Legnica
- Line 310: Kobierzyce - Piława (Ząbkowice) under construction
- **loading siding right next** to the train station



# Railway siding

- Located ca. 3 km from the site
- Service Infrastructure Facility, Track No. 6
- Usable area 254m
- Unloading terminal - 128m (shortened due to existing building)





# Wrocław Airport Expansion

In 2024, a fuel base was built:

- 4 above-ground JET A-1 aviation fuel tanks
- capacity 400m<sup>3</sup>2 reloading modules enabling high capacity tanker refueling
- 1 unloading module
- 1 tank drainage station



2025:

- new parking apron for 14 aircraft,
- rapid exit road,
- new 2.5 km taxiway,
- de-icing area,
- reconstruction of existing taxiways.

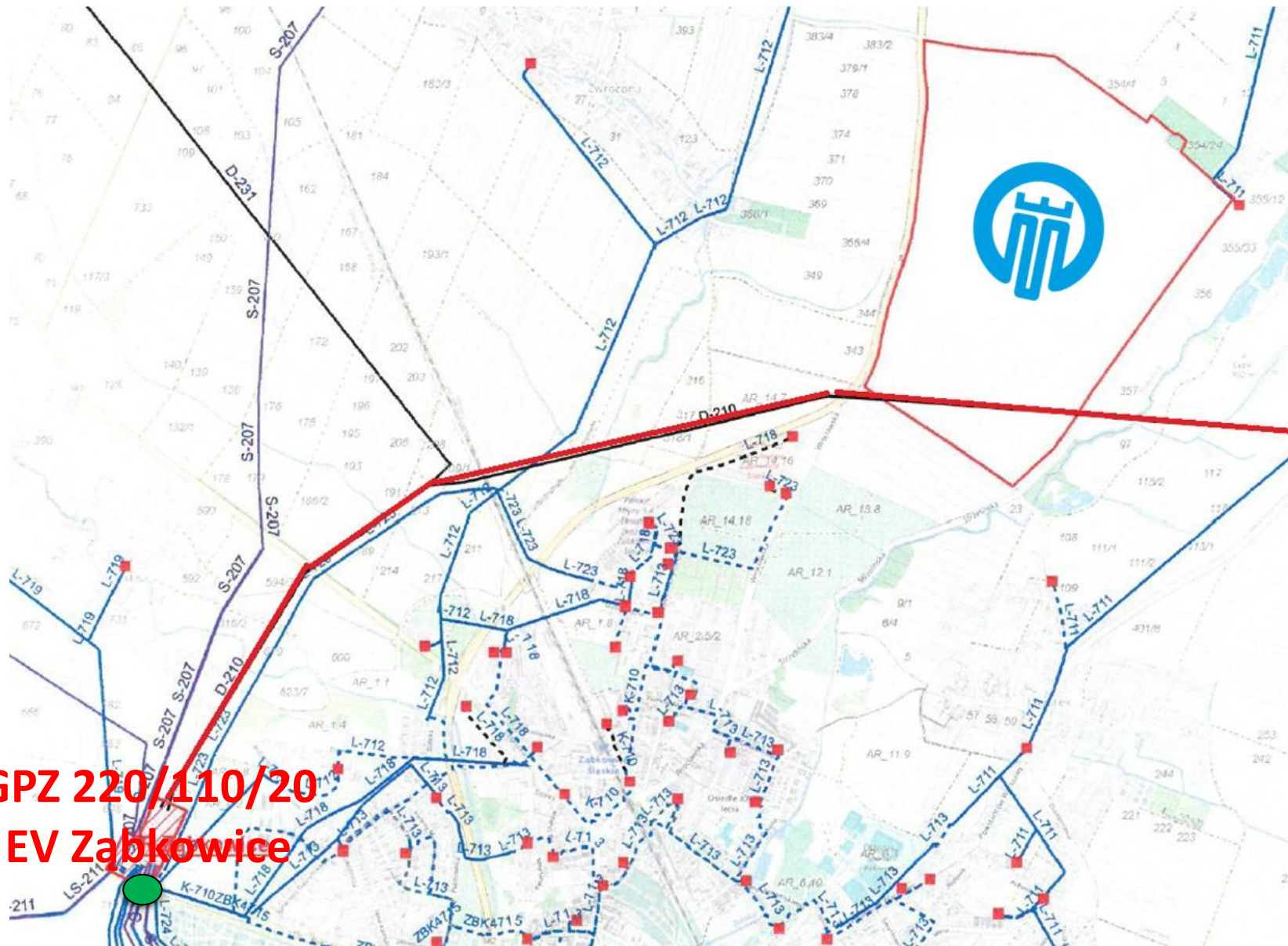

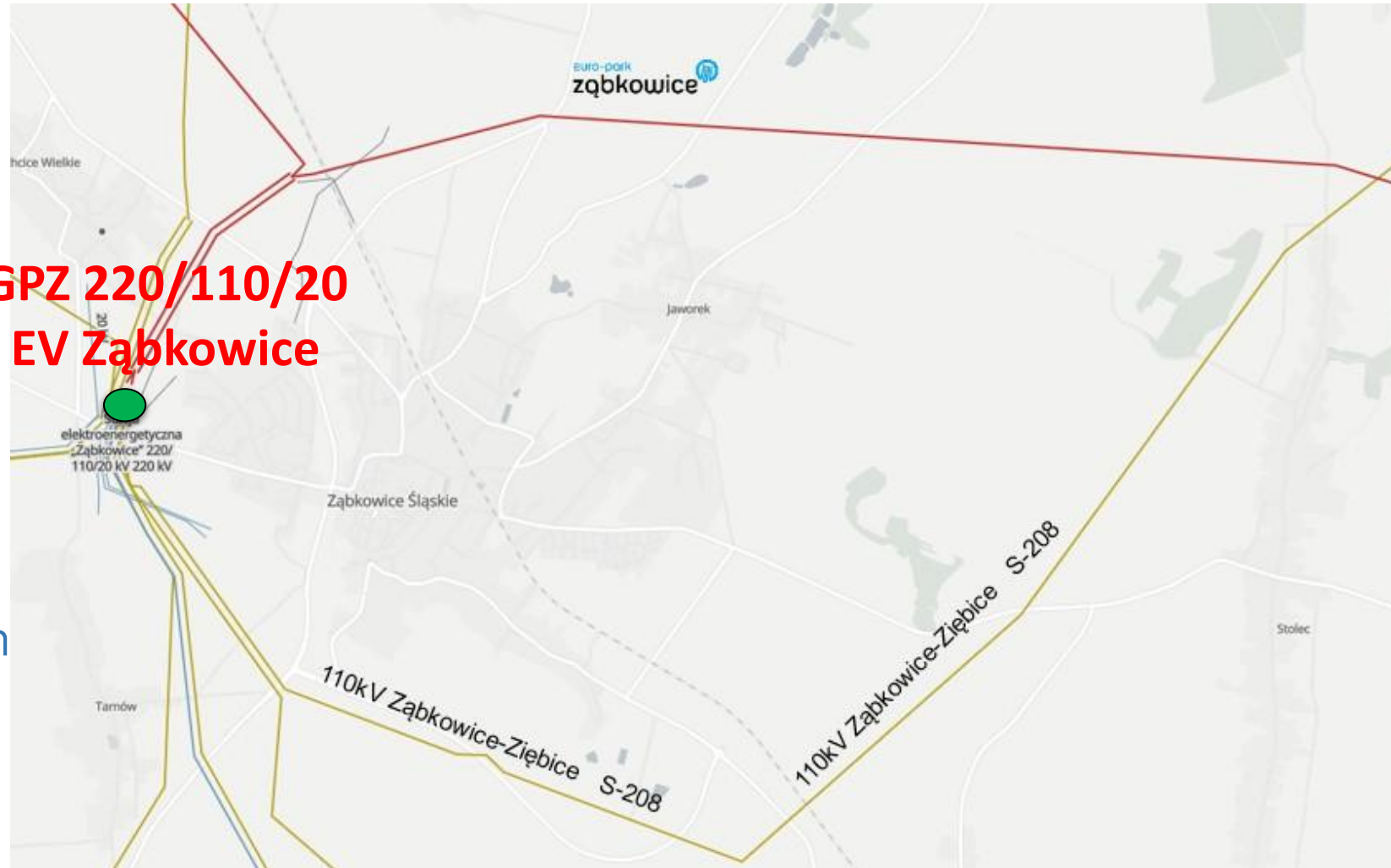

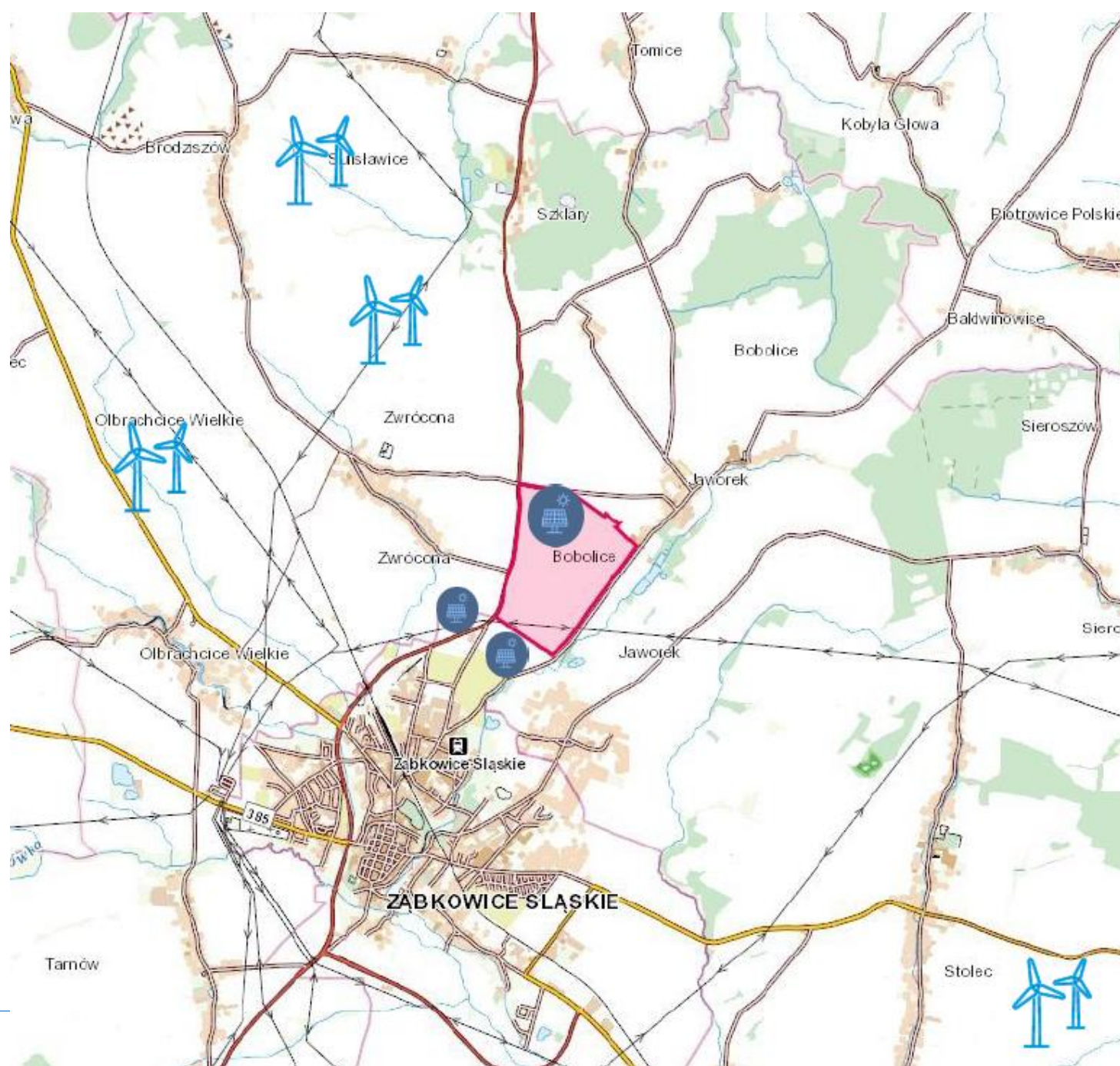

# GAS SUPPLY

- Gas reduction and metering station (ZZU Zwrócona) on a high-pressure gas pipeline with a pressure of 6.3 MPa.
- Connected to a distribution gas pipeline of increased medium pressure DN 250 and DN 200-PN, 1.6 Mpa.
- A detailed description of the possibilities and conditions for supplying the area with gas will be possible after obtaining the preliminary conditions for connecting the property to the gas network.

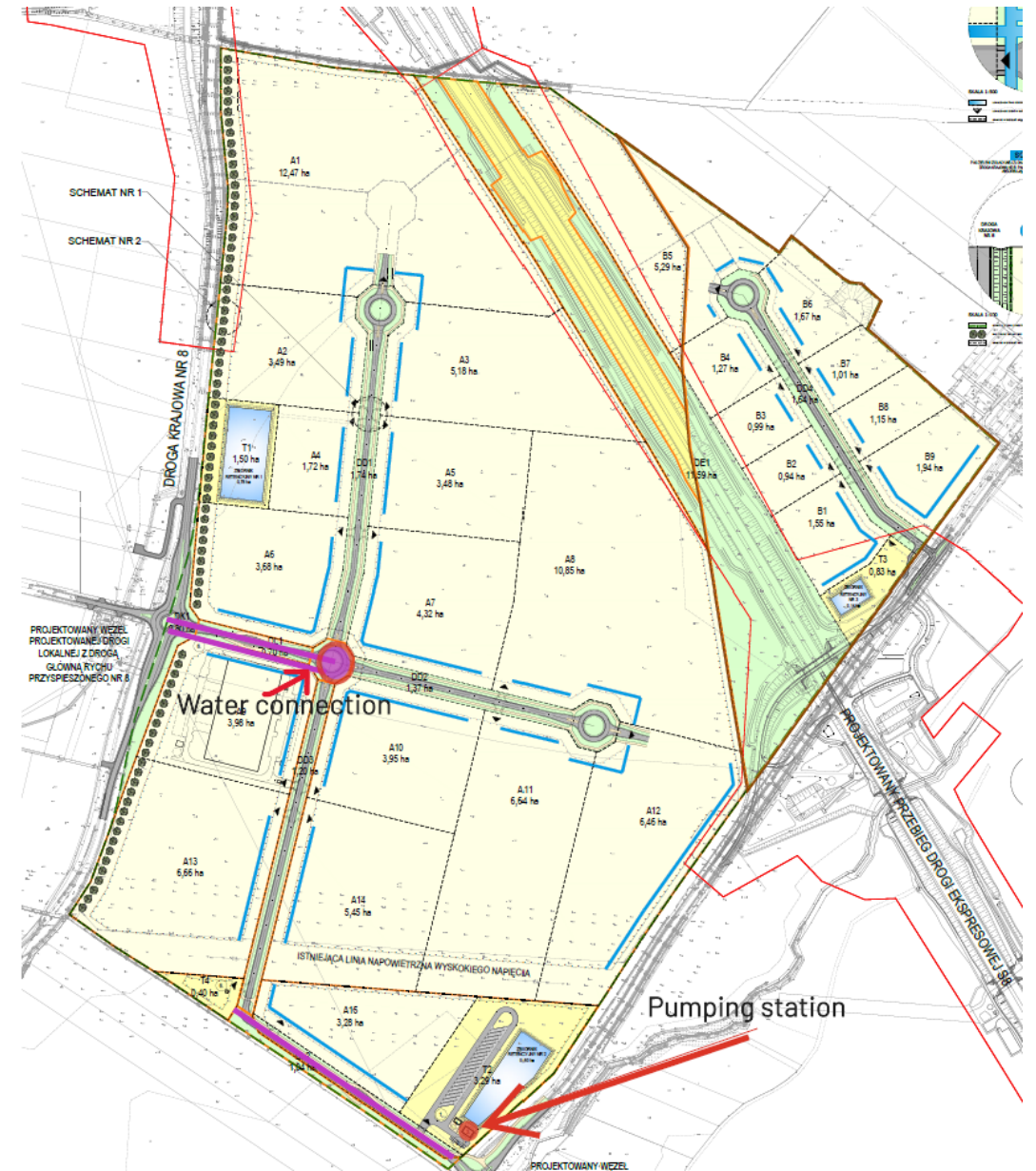


# WATER SUPPLY SYSTEM

As part of the development of the EURO-PARK Zabkowice Śląskie Investment Zone, **significant investments in the water and sewage infrastructure are being made.**

Scope of the works:

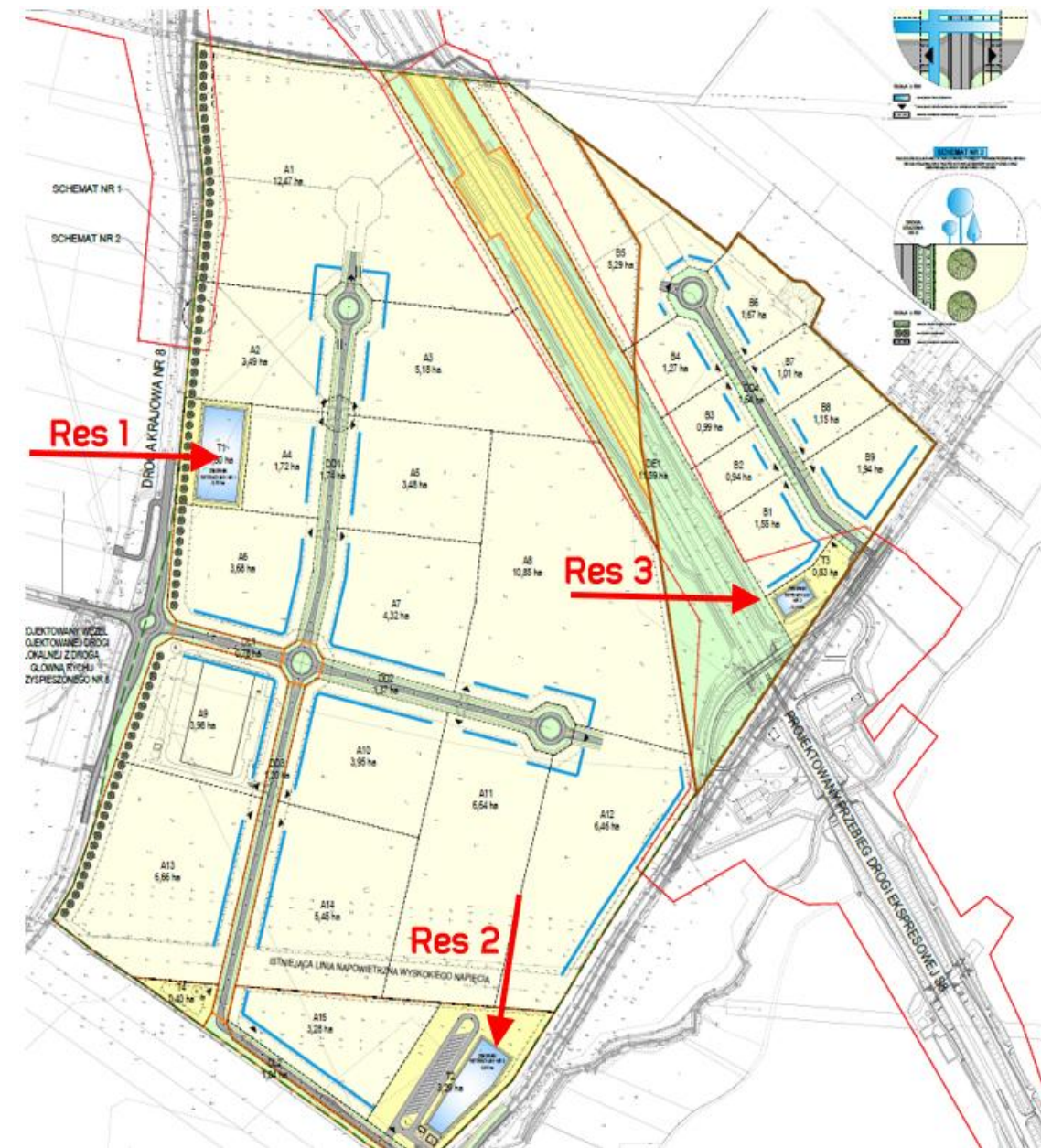
- Modernisation of the wastewater treatment plant on Rzeczna Street;
- Modernisation of the water intake in Olbrachcice Wielkie;
- Construction of water transmission network: Connecting the intakes in Olbrachcice Wielkie with the area of the Investment Zone.
- Extension and reconstruction of the sanitary sewage system: Ensuring efficient sewage disposal in the Investment Area.





# Rainwater

- Preliminary decisions on rainwater drainage in the EURO-PARK area have been issued;
- EPZ shall take charge of some rainwater at the site, but the Investor is obliged to partially manage the rainwater at the investor's plot
- Drainage system with three retention basins was prepared:
  - 1 retention-infiltration-evaporation reservoir (reservoir 3)
  - 2 retention and evaporation reservoirs (reservoirs 1 and 2)
- The system will be adapted to the level of development and the needs of the investors.

- implementation of the initial investment
- maximum aid - up to 25% of eligible costs
- up to 5 years

## CONDITIONS:

- financial contribution - at least 25%,
- completion of the initial investment within 3 years,
- continuation of the investment for at least 5 years



## EXAMPLE

Planned total eligible costs: **PLN 14 020 000 net**

Maximum aid intensity for a large entrepreneur in the Dolnośląskie Voivodeship: **25%**

**14 020 000 x 25% = PLN 3 505 000**

**Amount of public aid available: PLN 3 505 000.**

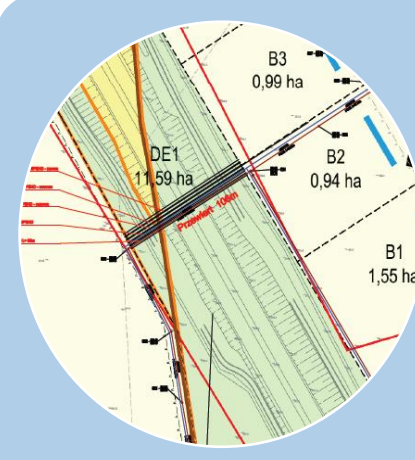

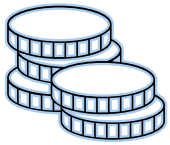
